

Request for Registration in the Doctors Residency Programs

About the Service

This service enables doctors to enroll in residency programs and obtain the necessary training in health facilities of the Emirates Health Services to receive the required medical speciality.

Service Process

- Register in the digital-services and make user name and password (If not yet registered), and login
- Submit the application for the service via the web-services.
- Attach all requested documents.
- Pay application fees
- The applications are reviewed and the applicants will be informed of the final status of their application.
- The applicant will be added to the list of nominees for enrollment in residency programs

Required Documents

- Copy of Bachelor Degree Certificate.
- Copy of transcript
- Copy of Internship Certificate
- Copy of Experience Certificate (If any)
- Copy of valid EMREE (Emirates Medical Residency Entrance Examination) results
- Copy of valid English language Proficiency scores (OET/TOEFL/IELTS Result) For Graduates from outside UAE
- Statement of Purpose/ Letter of Intent
- Two Letters of Recommendation
- Approval letter from facility director (only for EHS employees)
- Copy of valid Passport
- Copy of valid Emirates ID Card (If available)
- Copy of valid UAE Residency Visa (If available)
- Copy of family book (for UAE Nationals only)
- Personal Photo
- CV
- National Service Letter (for male UAE Nationals only)
- Copy of birth certificate
- Copy of Primary Source Verification Report for all certificates
- All Certificates issued outside UAE shall be attested and equivalized from: UAE Embassy of the issuing country. Ministry of Foreign Affairs in UAE. Ministry of Education in UAE.

Conditions & Requirements

1. The applicant must have a Bachelor degree (MBBS or equivalent) from an accredited Medical College/University

2. The applicant must have a successful completion of Internship.
3. The time laps since graduation and Internship should be less than five years and 4 years respectively.
4. Abruption in active clinical practice should not exceed 12 months.

5. The applicant must pass EMREE exam offered by NIHS (National Institute for Health Specialties) successfully <https://fmhsmeb.uaeu.ac.ae>
6. Graduates from colleges/universities outside UAE must pass the English Proficiency Test (with a score of at least 80 in TOEFL IBT or 6 in IELTS Academic or C+ in OET).
7. The acceptance of registration in the doctor residency programs means that the applicant is qualified to apply to the residency program and does not mean acceptance to enroll in the program. Acceptance in the program is determined based on several factors including passing Interviews and the availability of vacant training seats,
